CIRCULAR

The Technical Support Group (TSG) Lunglei, meeting held on 7th October, 2021, approved the constitution of Village Implementation Committee (VIC) under Green Ag Project in the villages enclosed. In pursuant of the approve agenda the line Department Heads under Lunglei district are instructed to issue official circular and inform their field functionaries/Village Council/President at the village level to support the formation of VIC which will act as decision making unit at the village level. The Village Implementation Committee (VIC) will be pivotal in Green-Ag for making plan, its implementation and monitoring at their respective villages. Training for the constituted committee will be done by the project staff at their respective villages.

The District Heads are to undergo regular follow-ups within their respective field functionaries regarding the status of project implementation in their domain areas at the respective villages.

Periodic review meetings should be held by the District Heads with their field functionaries to discuss the progress of the project, remedial actions or obstacles if any. Green Landscape Implementation Unit (GLIU), Green-Ag. Project representatives maybe invited in these meetings.

Progress updates should be given by the District Heads in every TSG meetings with respect to their domain areas and offer suggestive steps for course correction in the project implementation.

Provisional Structure of VIC

Please find below a provisional structure of VIC, subject to modifications based on the inputs of the Sarpanch or Panch/ Chairman, Village Council, and other local representatives

1. The Sarpanch or Panch/ Chairman, Village Council, or any member of the village council with the concurrence of Sarpanch/ Chairman, VC shall be the Chairman of a VIC
2. Various other committees working in the village shall nominate their representatives for a VIC in a written form
3. The Community Resource Person shall be the Member Secretary of a VIC.
4. All the Government officials from different line departments having jurisdiction of that village shall be Ex-officio members of a VIC.
5. At least one-third of the members of a VIC shall be women.
6. Adequate representation shall be given to the indigenous communities and at least two members shall be from these communities
7. At least one member of the landless class of the village shall be a member
8. A VIC shall meet as and when required but at least once in a month.
9. If the chairman is absent due to any reason, the members may nominate any one among them to preside over the meeting on that particular day
