- Ensure all project outputs are in accordance with the Project Document;


- Ensure synergy in project implementation between various Government Departments, donors, private sector interventions, and project stakeholders;
- Review, amend if appropriate, and approve the draft State Annual Work Plan and Budget of the project for submission to FAO;
- Facilitate the “mainstreaming” of relevant project findings and recommendations into State Policies, Plans and Strategies;
- Facilitate incorporation and mainstreaming of the Gender and Social Inclusion component;
- Appraise the project on any proposed government plans, policies, investments that might be relevant to the project and facilitate sharing of relevant good practices from other parts of the State;
- Support management responses preparation to independent mid-term review and final evaluation of the project;
- Facilitate coordination and linkages of project activities with Central Schemes and sharing/ learning with other states, involved in this project.
- The State Steering Committee will meet at least twice in a year or more as decided by the committee.
