MINUTES OF THE THIRD TECHNICAL SUPPORT GROUP (TSG) MEETING, GREEN LANDSCAPE IMPLEMENTATION UNIT (GLIU), LUNGLEI GREEN – AG PROJECT

The meeting starts at 11:00 am with a warm welcome from the Deputy Commissioner, Lunglei and Chairman of The TSG meeting. He thanked all the members present from Lunglei as well as Mamit and staffs from NPMU who joined the meeting through virtual mode. He is pleased to see the progress of the project so far in Mizoram despite the Covid 19 pandemic, and he urges the line departments of the TSG members to continue to render their support fervently in order to achieve the targets of the Project.

This was followed by introduction from the NPMU and DC Mamit who attended the meeting through virtual mode. From NPMU Dr. Divya Shah, NRM & Biodiversity Specialist, Ms. Uma Balaji, Admin & Operations Officer & Nodal Officer for Mizoram state, and Mr. Sudhakar Yerrakonda, FFS Expert of the Green-Ag Project joined the meeting from Delhi through Virtual mode. From Mamit, Mr. Beitlotha Nohro, Settlement Officer represents the meeting as Chairman of the TSG.

Progress Report of the GLIU team from 7th October 2021 to 6th March 2022:

Mr. C. Malsawmkima, Member Secretary, TSG and District Agriculture Officer, Lunglei gave a detailed progress report of the GLIU team from 7th October 2021 to 6th March 2022. The detailed progress report is enclosed.

Agenda discussion:

As per permission and instruction by the Chairman, Mrs. Lalchhuanawmi Pachuau, Team Leader, GLIU, Green Ag Project gave an elaborated power point presentation on the draft Annual Work Plan and Budget (AWP&B) for the year 2022-2023, the draft Action Plan for 1st Quarter (April-June) 2022-2023, the Team Leader also informed the committee that, the activities, target and budget are subject to changes as it goes through higher level Committees. A presentation was also given on Geospatial analysis data on Dampa Landscape for the Identification and Approval of High Priority Areas.

After detailed discussion by the members, the following agendas are approved by the meeting: -

- 1. The meeting agreed upon the proposed activities under the Draft Annual Work Plan and Budget for the year 2022-2023.
- 2. The Action Plan for three months (April June, 2023) was approved by the committee.
- 3. Based on the Geospatial Analysis and Secondary Literature Review it is identified that there are 17 villages in Dampa Landscape (13 in Mamit & 4 in Lunglei). Therefore, after considering the results from the assessment data presented by the Team Leader, Green Ag Project, 17 villages under the landscape are put before Technical Support Group of Mamit & Lunglei district and approved as High Priority Areas. The approved High Priority Areas for implementation of activities are as follows:

1. The Chairman suggested that the Geospatial data of the Project Landscape should be shared to the Department of Land Resource, Soil and Water Conservation for further validation of the existing data.

- 2. The Chairman suggested that the following village level information should be acquired from the Line Departments by issuing a formal letter.
 - a. Land holding pattern- district level available
 - b. Women farmers
 - c. Agriculture land use pattern- block level available
 - d. Change in pattern of major crop cultivation-block level available
 - e. Area and production of main crops- district level available
 - f. Agricultural labor availability- block level available
 - g. Mechanization
 - h. Irrigation- block level available
