

Minutes of SSC meeting on Green-Ag Project

The 3rd meeting of State Steering Committee (SSC) on "Green-Ag Project" funded under Global Environment Facility-FAO, was held through V. C. under the Chairpersonship of Chief Secretary, Government of Rajasthan on 18th July 2022 at 4.30 PM. List of participants is enclosed at Annexure-1.

Commissioner Agriculture, GoR, welcomed all the Committee members present and briefed the house about various issues in project area, action to be taken, present status of implementation of the project, future interventions etc. In meeting, agenda wise presentation was done.

Project Director, Green-Ag project, New Delhi is opined that the salary of manpower engaging in field activities will have to reimburse in regular mode. He focused on the strategies for ensuring effective convergence of ongoing governmental schemes in project area. He explained that the selection of high priority villages were done on the basis of geospatial survey.

Principal Secretary Agriculture highlighted that convergence of agriculture & horticulture schemes should be implemented in project area on priority basis. He requested to all the line departments for effective convergence of their schemes in project area.

Chairman of SSC and Chief Secretary Ma'am, GoR, after detailed discussion on project & views of members, directed to execute the programme in a way to attain the project objectives in scheduled time.

After detailed discussion, following decisions were taken in the meeting-

1. HR Agency should make the payment on monthly basis to manpower working in the project and department will timely re-imburse it to HR agency as per terms & condition of contract.
2. District Collector, Jaisalmer & Barmer are directed to monitor the project regularly and make an effective convergence of all line departmental schemes.
3. Identified high priority villages should be placed for approval in next TSG meeting. So that work in high priority areas could be initiated.

The meeting ended with vote of thanks.
